C-59--Kahlotus Substation

In Franklin County, State of Washington:

C-59 Item: That portion of the northeast quarter of Section 5, Township 13 North, Range 34, East of Willamette Meridian, described as follows:

Beginning at a point where the center of the Company's transmission line (Item D38) intersects the northerly line of the county road on the northerly side of the Oregon-Washington Railroad & Navigation Company's right of way through said subdivision; thence easterly along said county road line to a point 75 feet distant, at right angle, from the center of said transmission line; thence northeasterly, parallel with the center of said transmission line, 100 feet; thence northwesterly, crossing said transmission at right angle, 150 feet; thence southwesterly, parallel with the center of said transmission line, 128.6 feet, more or less, to the county road line aforesaid; thence easterly along said road line to the point of beginning; containing 0.393 acres, more or less.
