- D-24 Line: From Cline Falls Hydroelectric Generating Plant (A-9) to Redmond Substation (C-8), all in Deschutes County, State of Oregon.
- D-25 Line: From Ochoco lumber Company's mill, near Prineville, Oregon, to Redmond Substation (C-8), all in Crook and Deschutes counties, State of Oregon.
- D-26 Line: From Cove Hydroelectric Generating Plant (A-10) to Redmond Substation (C-8), all in Deschutes and Jefferson counties, State of Oregon, except portion under contract of purchase from U.S.A.
- D-27 Line: Feeder line from D-26 Line to Decolite Corporation's plant northwest of Redmond, all in Deschutes County, State of Oregon.
- D-28 Line: From Warm Springs Lumber Company's mill, near the Warm Springs Indian Agency on the Deschutes River, to Cove Hydroelectric Generating Plant (A-10), all in Jefferson County, State of Oregon.
- D-29 Line: From Wallowa Falls Hydroelectric Generating Plant (A-11) to the Town of Wallowa, all in Wallowa County, State of Oregon.
- D-30 Line: From connection with D-37 line at the Columbia River crossing, near Umatilla, Oregon, to Pendleton Substation (C-39), all in Umatilla County, State of Oregon.
- D-31 Line: From Pendleton Substation (C-39) to Freewater Substation (C-36), all in Umatilla County, State of Oregon.
- D-32 Line: From Walla Walla River Hydroelectric Generating Plant (A-7) to Freewater Substation (C-36), all in Umatilla County, State of Oregon.
- D-33 Line: From Freewater Substation (C-36) to Walla Walla Substation and Switching Station (C-65), all in Umatilla County, State of Oregon, and Walla Walla County, State of Washington.
- D-34 Line: From Walla Walla Substation and Switching Station (C-65) to Pomeroy Substation (C-61) and junction with electric transmission line to The Washington Water Power Company, all in Walla Walla, Columbia, and Garfield counties, State of Washington.
- D-35 Line: From Walla Walla Substation and Switching Station (C-65) westerly to connection with Bonneville Power Administration's transmission line at its Walla Walla Substation, all in Walla Walla County, State of Washington.
- D-36 Line: From Walla Walla Substation and Switching Station (C-65) to Pasco Substation and Switching Station (C-60), all in Walla Walla and Franklin counties, State of Washington.
- D-37 Line: From Pasco Substation and Switching Station (C-60) to connection with D-30 Line at the Columbia River crossing near Umatilla, Oregon, all in Franklin and Benton counties, State of Washington.
- D-38 Line: From Pasco Substation and Switching Station (C-60) to Lind Substation (C-45) and junction with electric transmission line of The Washington Water Power Company, all in Franklin and Adams counties, State of Washington.
- D-39 Line: From Pasco Substation and Switching Station (C-60) to connection with Bonneville Power Administration's electric transmission line at its Pasco Switching Station, all in Franklin County, State of Washington.
- D-40 Line: From Pasco Substation and Switching Station (C-60) westerly along the Columbia River to a connection with the electric transmission line of Hanford Engineer Works, a U. S. Government project, all in Franklin County, State of Washington.
- D-41 Line: From Pasco Substation and Switching Station (C-60) to Union Gap Substation and Switching Station (C-75), all in Franklin, Benton, and Yakima counties, State of Washington.
