- J-18 Item 8: The west half of the southwest quarter of Section 20, Township 6 North, Range 11 East of Willamette Meridian.
- J-18 Item 9: All that part of the south half of the southeast quarter of Section 24, Township 3 North, Range 12 East of Willamette Meridian, lying within a 40 foot right of way as measured 20 feet each side of the center line of that certain flume canal or pipe line, surveyed and staked upon and across said land, according to the field notes of said survey as heretofore made by F. C. Kelsey and George S. Canfield in the year 1908, and as conveyed to Northwestern Electric Company by Sheriff's Deed dated March 26, 1921, and recorded in Book 52D of the deed records of Klickitat County at page 593.

- J-18 Item 11: The southwest quarter of the northeast quarter, the south half of the northwest quarter, and the north half of the southwest quarter of Section 25, Township 3 North, Range 12 East of Willamette Meridian; also that portion of the northwest quarter of the northeast quarter of said section lying westerly of a line 50 feet easterly from and parallel with the left bank of Klickitat Kiver, except county road and right of way of Spokane, Portland & Seattle Railway Company.
