Lot numbered nine (9) in Block six (6) of Johnson's Addition to the Town of Stevenson, according to the official plat thereof on file and of record in the office of the Auditor of Skamania County, Washington; also all easements and rights of way and other rights appurtenant to said lot, including a right of way for a private road over a strip of land ten feet in width along the south side of Lots 2, 3, 4, and 5 in said Block 6, and a strip 4 feet in width along the north line of lots 6, 7, and 8 in said Block 6 and a strip 10 feet in width on lot 1 in said block, commencing 6 feet north of the northeast corner of lot 10, thence west 60 feet, thence north 10 feet, thence east 60 feet, thence south 10 feet, also the right to lay a drain pipe on said strip.
