Byers, a widow, party of the first part, for and in consideration of the sum of one dollar and other considerations to her in hand paid by Bertha Angeline Burns, a widow, party of the second part, has GRANTED, BARGAINED and SOLD, and by these presents does hereby Grant, Bargain, Sell and Convey unto the said party of the second part, and to her heirs and assigns, the following described real property in Skamania County, Washington, to-wit:

The Southeast quarter of the Northeast quarter (SE $\frac{1}{4}$ NE $\frac{1}{4}$ ), Northeast quarter of Southeast quarter (NE $\frac{1}{4}$ SE $\frac{1}{4}$ ) and South half of Southeast quarter (S $\frac{1}{2}$  SE $\frac{1}{4}$ ) of Section twenty-nine (29) township two (2) North range five (5) East, W. M., save and except that certain 6.7 acres thereof, more or less, deeded to Lester A. Burns and heretofore recorded in deed records of Skamania County, Washington, to which reference is hereby made. The property hereby conveyed consisting of 153.3 acres, more or less.
