This Indenture Witnesseth, That H. Stuart Dollar, unmarried, and of legal age, who is the same person and identical with Stuart Hamilton Dollar, who is the son of A. Dollar, also deceased, party of the first part, for and in consideration of the sum of Twenty-five and no/100 (\$25.00) Dollars, lawful money of the United States of America, to him in hand paid by John Kraetch, of Portland, Oregon, party of the second part, does by these presents REMISE, RELEASE, CONVEY and QUIT CLAIM unto said party of the second part his heirs and assigns, all interest of the said party of the first part in and to the following described real property, situated in Skamania County, State of Washington, to-wit:

The Donation Land Claim of Samuel M. Hamilton and his wife, Mary Jane Hamilton, designated as claim number 40, being parts of Sections 19, 20, 29 and 30 in Twp. 2 North, of Range 7 East of Willamette Meridian, and being bounded and described as follows, to-wit: Beginning at a point four chains south and 27 chains and 20 links east of the Northwest corner of said Section 20 and running thence West 62 chains; thence south 22 deg.
