Bruce Murray, her husband, parties of the first part, for and in consideration of the sum of Seventy-Five and no/100 (\$75.00) Dollars, lawful money of the United States of America, to them in hand paid by John Kraetch, of Portland, Oregon, party of the second part, do by these presents REMISE, RELEASE, CONVEY and QUIT CLAIM unto said party of the second part his heirs and assigns, all interest of the said parties of the first part in and to the following described real property, situated in Skamania County, State of Washington, to-wit:

The Donation Land Claim of Samuel M. Hamilton and his wife, Mary Jane Hamilton, designated as claim number 40, being parts of Section 19, 20, 29 and 30 in Twp. 2 North, of Range 7 East of Willamette Meridian, and being bounded and described as follows, to-wit: Beginning at a point four chains South and 27 chains and 20 links east of the Northwest corner of said Section 20 and running thence West 62 chains; thence South 22 degrees East 135 chains; thence North 73 deg. and 15 min.
