This Indenture, Made and entered into this 1st day of June 1933 by and between Joseph S. Lilly and Ida M. Lilly, husband and wife and Lyle D. Quick, a single man, parties of the first part, and Joseph A. Salmonson and Dorothy M. Salmonson, husband and wife, parties of the second part, witnesseth:

That the said parties of the first part, for and in consideration of the sum of one dollar and other considerations, the receipt whereof is hereby confessed, do by these presents GRANT, BARGAIN, SELL and CONVEY unto the said parties of the second part the following described real property in Skamania County, State of Washington, to-wit:

Commencing at a point in the center of County Road 600 feet North 00° 52' West of the center of section 8, township 1 North of Range 5 East of the W.M., thence following the center line of said road North 00° 52' West 420 feet, more or less, to the west boundary of Lateral Highway No. 1, thence in a southerly direction along the west line of said Lateral Highway No. 1 a distance of 640 feet, more or less, to the center of a county road, thence along the center of said county road North 77° 10' West 440 feet, more or less, to point of beginning. EXCEPTING the one acre tract known as School District No. 29 tract. Containing 2.7 acres, less 1 acre, balance 1.7 acres.
