Thomas Underwood et ux to State of Washington

Permit to Stockpile Road Materials.

Whereas, Thomas Underwood and Nell Underwood, his wife are the owners of the following described tract of land, to-wit:

A tract of land in Lots 8 and 9 of Home Valley Tracts in Section 34, Township 3 North, Range 8 East, W. M., being more particularly described as follows:

Commencing at the NE corner of said Section 34; thence S. 1° 52' E. 546 feet along the easterly boundary line of said Section 34 to an intersection with the center line of State Road No. 8; thence N. 66° 31' W. 77 feet along said center line to the true point of beginning; thence N. 1° 59' W 213.6 feet; thence N. 82° 42' W 171 feet; thence S. 12° 7' W 200 feet to an intersection with the center line of said State Road No. 8; thence S 66° 31' E 240.9 feet along said center line to the place of beginning excepting therefrom the area of the right of way of said State Road No. 8 contained therein.

And Whereas, The State of Washington, in the improvement of State Road No. 8 desires to store road materials in stock piles upon the land hereinabove described,

Now Therefore, for and in consideration of the sum of Seventy five and no/100 Dollars, in hand paid, the receipt whereof is hereby acknowledged, and other valuable considerations, the right, privilege and permit is hereby granted unto the State of Washington to deposit and store in stockpiles road materials upon said land, provided, however, that no damage be done to surrounding land and improvements, and provided further that, upon the expiration of this permit, the said State of Washington will leave the permises hereby to be occupied in as good a condition as they originally were.

This permit is to be in effect for a period of 18 months from date hereof and will expire on _____.

The right and privilege of ingress and egress to and from the said land for the purposes herein specified is hereby granted.
