GERTRUDE H. LUTEN ET VIR TO EARL J. CUMMINS

KNOW ALL MEN BY THESE PRESENTS, That Gertrude H. Luten and Benjamin B. Cummins, party of the second part, do hereby REMISE, RELEASE, CONVEY and QUIT-CLAIM unto the party of the second part, his heirs and assigns, all their right, title and interest in and to the following described real property in Skamania County, State of Washington, to-wit:

1. The SE $\frac{1}{4}$ of section 19 tp. 3 N. R. 10 E. W. M., excepting a strip of land containing 4 acres more or less along the north side thereof, and public roads.

2. Also; beginning at a point on the section line between sections 18 and 17 tp. 3 N. R. 10 E. W. M., 66 $\frac{2}{3}$ rds south of the northeast corner of the SE $\frac{1}{4}$ of said section 18, thence running west 320 rods to the township line between ranges 9 and 10 east of W.
