Cordier party of the second part, has GRANTED, BARGAINED and SOLD, and by these presents do Grant, Bargain, Sell and Convey unto the said party of the second part, and to his heirs and assigns, the following described real property, situate, lying and being in the County of Skamania, State of Washington, to-wit:

Beginning at a point from which the corner to sections 14, 15, 22 & 23, Township 3 North Range 10 East of W. M. bears N. 89 degrees 48 minutes east 1327.6 feet distant, said point being the middle of the south line of the southeast quarter of section 15 aforesaid; thence northward 660 feet along the line common to the Southwest quarter and Southeast quarter of the Southeast quarter of said section 15; thence westward 198 feet on a line parallel to the south line of said quarter section; thence southward 660 feet to the south line of said quarter section; thence eastward 198 feet to the point of beginning; said tract containing three acres, more or less, saving and excepting from the above tract, a strip of land seven & one-half feet in width along the east side of said tract.
