Witnesseth; that the said party of the first part, for and in consideration of the sum of Ten & no/100 Dollars, lawful money of the United States of America, the receipt whereof is hereby acknowledged, does by these presents GRANT, BARGAIN, SELL and CONVEY unto the said party of the second part, and to his heirs and assigns forever, all those certain lots, pieces, or parcels of land, situate, lying and being in the county of Skamania State of Washington, and bounded and particularly described as follows, to-wit:

The Northeast quarter of the Northwest quarter and the east half of the east half of the northwest quarter of the northwest quarter of section eight (8) in Township one (1) North of range five (5) East of the Willamette Meridian, containing 50 acres; except a parcel of land 1.20 acres heretofore deeded to Belle Center Congragational Church & Cemetery Association.

Together with all and singular the tenements, hereditaments and appurtenances thereunto belonging, or in any wise appertaining; the reversion and reversions, remainder and remainders, rents, issues and profits thereof,

To Have and to hold, all and singular, the above mentioned and described premises, together with the appurtenances, unto the said party of the second part, and to his heirs and assigns forever.

And the said party of the first part and her heirs, shall and will WARRANT and DEFEND and by these presents does forever WARRANT and Defend the said premises in the quiet and peaceful possession of the said party of the second part his heirs and assigns against all persons whomsoever lawfully claiming or to claim any right, title or interest in the same.
