Sheriff's Deed.

This Indenture, Made on the 24th day of August A. D. One Thousand Nine Hundred Thirty three by and between A. P. Gordon Sheriff of Skamania County, the party of the first part and The Federal Land Bank of Spokane, a corporation, of the County of Spokane and _____ of _____ the party of the second part,

Witnesseth, That whereas, by virtue of an order of sale, issued out of and under the seal of the Superior Court of Washington, and for the County of Skamania, holding terms at Stevenson, tested on the 10th day of June A. D. 1932 (upon a judgment rendered in said Court on the 10th day of June A. D. 1932) in favor of The Federal Land Bank of Spokane, a corporation, plaintiff and against Bernard A. Haffey; W. T. Mattison and Esther Mattison, husband and wife; Harry M. Sterns and Jane Doe Sterns, wife of Harry M. Sterns; George S. Moody and Jane Doe Moody, wife of George S. Moody, and Skamania County National Farm Loan Association, a corporation, defendants, Case No. 1987 and to A. P. Gordon the then acting Sheriff of Skamania County, Washington, directed and delivered, commanding him that he should sell the premises hereinafter described, in the manner prescribed by law;

And Whereas, the said A. P. Gordon Sheriff as aforesaid, did on the 16th day of July A. D. 1932 sell the hereinafter described real estate at public auction at the court house door in Skamania County, Washington, after having first given due notice of time and place of said sale, by advertising according to law;

And Whereas, at said sale, The Federal Land Bank of Spokane, a corporation became the purchaser of the real estate hereinafter described, for the sum of One Thousand Five Hundred Twenty & 46/100 Dollars (\$1520.46) by reason of being the highest bidder therefor at said sale.

And Whereas, said sale has been in all things confirmed by the said Court, and the time for redemption having now fully expired, and no application having been made to redeem the hereinafter described premises;

Now, therefore, I A. P. Gordon Sheriff as aforesaid, the party of the first part, in pursuance of the statute in such case made and provided, and for and in consideration of the
