Gordon Sheriff of Skamania County, Washington, do hereby GRANT, BARGAIN, SELL, <sup>confirm</sup> and CONFIRM unto the said The Federal Land Bank of Spokane, a corporation, its heirs and assigns forever, all the right, title and interest of the said defendants and each of them in and to the following described real estate, to-wit:

The Southwest Quarter of the Northeast quarter of Section Four, Township One North, Range Five East of the Willamette Meridian, excepting therefrom the East Half of the East Half of said Southwest Quarter of the Northeast Quarter, containing 30 acres.

Also, commencing at the Southeast corner of the Homestead heretofore set apart by order of Court for the use of Mrs. Catherine Haffey and her minor child, and run thence East along the South line of the real estate belonging to the estate of William Haffey, deceased, 80 rods and 16 links to the Southeast corner of said real estate belonging to said estate, thence north along the East line of said real estate belonging to said Estate 39 rods and 9 links, thence West 20° 30' 80 rods and 16 links to the East line of said Homestead, thence South along the East line of said Homestead Thirty-nine rods and 9 links to the place of beginning containing 20 acres in Section Four, Township One North, Range Five East of Willamette Meridian.
