And I hereby appoint J. D. Currie, Attorney, of Camas, Clark County, Washington, executor, of this my Last Will and Testament, requiring him to furnish a bond, but giving him full power and authority to sell and dispose of the real estate belonging to me, without the intervention of the court, for such reasonable prices and terms as he may be able to get.
