Guardian's Deed.

This Indenture, made and entered into this 20th day of September, 1933 by and between Raymond C. Sly, the duly appointed, qualified and acting guardian of E. W. Huckins, an insane person, as grantor, and Charles Larson, as grantee, Witnesseth:

Whereas, the said E. W. Huckins is an insane person; and

Whereas, the said Raymond C. Sly has heretofore, in the Superior Court of the State of Washington, in and for the County of Skamania, been appointed and has qualified as guardian of the said insane person; and

Whereas, by order of said superior court, the said Raymond C. Sly, as such guardian, was authorized and directed to sell the real property belonging to the said insane person at private sale; and

Whereas, after due notice being published and posted as required by law, the said Raymond C. Sly did sell the property hereinafter described to the grantee, subject to the confirmation by said court; and

Whereas, after return of said sale being duly made to the court, and after said return had been on file herein more than ten days, the court entered its order confirming said sale.
