for and in consideration of Ten (\$10.00) Dollars in hand paid, CONVEY and WARRANT to Moffetts Hot Springs Co., a corporation, the following described real estate situated in the County of Skamania, State of Washington, to-wit:

Beginning at the Northeast corner of the Isaac Bush D. L. C. No. 296, said corner being 5.90 chains North 29° East from the quarter corner between Sections 10 and 11, Township 2 North, Range 7 East of the Willamette Meridian, and running thence West, along the North line of said Bush Claim, to the Northwest corner thereof; thence along the West line of the Bush D. L. C. to the center line of said Section 10; thence West, along the center line of said Section 10, to the center thereof; thence South, along the center line of said Section 10. to the Southwest corner of Lot 9 in said Section 10; thence West, along the North line of Lots 5 and 4 in said Section 10, to the West line of said Section 10; thence South, along the West line of Section 10, to the Southwest corner of Lot 4 therein; thence East, along the South line of Lots 4 and 5 to the center line of Section 15; thence South, along the center line of said Section 15, to the center thereof; thence West, along the center line of said section 15, to the West line of Section 15; thence South, between Sections 15 and 16, 80 rods; thence West, along the North line of Chenowith D.
