lst.-- The purchase price for said land is Two thousand & no/100 (\$2,000.00) Dollars, of which the sum of One hundred (100) dollars has this day been paid as earnest, the receipt whereof is hereby acknowledged by said party of the first part; balance of said purchase price to be paid as follows, to-wit:

The sum of One Hundred (100) Dollars to be paid on the First day of November A.
