Know All Men by These presents, That Warren Packing Company, a corporation organized and existing under the laws of the State of Oregon, and authorized to do business in the State of Washington, on consideration of One Hundred Dollars (\$100.00) and other valuable considerations to it paid by Warren Estate Company, an Oregon corporation, does hereby GRANT, BARGA IN, SELL and CONVEY unto said Warren Estate Company, its successors and assigns forever, the following described real properties situated in the States of Oregon and Washington, te-wit:

Real Properties in the State of Oregon:

(A) Bradford's Island, more particularly described as follows:

Lots numbered 5 and 6 of section 21, and lots numbered 5 and 6 of section 22 in township 2 North, of Range 7 East, of the Willamette Meridian, said tract being situated in the County of Multnomah.

(B) Salmon Island, sometimes known as Boat Rock, more particularly described as follows:

Lot numbered 7 in Section numbered 22, in Township 2 North of Range 7 East of the Willamette Meridian, said tract being situated in the County of Multnomah.

Real Properties in Skamania County in the State of Washington:

(A) A portion of the B. B. Bishop Donation Land Claim Number 39 in Sections 20 and 21, Township 2 North, Range 7 East, of the Willamette Meridian, bounded and described as follows:
