Right of Way Agreement.

This Indenture Witnesseth, That, Agate Erickson of Skamania County, Washington for and in consideration of the sum of One Dollar, lawfull money of the United States to her in hand paid by Ethel Houser, the said Agate Erikson GRANTS TO the said Ethel Houser a right of way for free and unrestricted passage over the present road leading in an easterly direction to the county road along the north line of Lots 2 and 3 and the E $\frac{1}{2}$ of SW $\frac{1}{4}$ of Sec. 26, Twp. 3 N. R. 8 E. W. M. Said right of way shall continue in force untill such time as there shall be established a Public road other other suitable outlet to the property of said Ethel Houser. And it is further provided that Ethel Houser shall keep all gates properly closed that Agate Erickson may erect across said road for her own use to keep in her cattle.

THIS INDENTURE WITNESSETH, That Beacon Lake Corporation, a corporation, party of the first part, for and in consideration of the sum of One Dollar in lawful money of the United States, to it in hand paid by Ella C. Pedersen, party of the second part, has GRANTED, BARGAINED and SOLD, and by these presents does Grant, Bargain, Sell and Convey unto the said party of the second part, and to her heirs and assigns, the following described real property situate, lying and being in the County of Skamania, State of Washington, to-wit:

Commencing at a point on the East line of Section 26, Twp. 2 N. R. 6 E. W. M. 208 feet South of the quarter corner, thence West 208 feet, thence North 208 feet to the center line, thence West 342 feet to a stake 3 inches square from which a fir tree 4 feet in diameter bears S 45° East 3 feet distant marked "P", thence South 200 feet to a point on the North side of Kuffler Road marked by a maple tree 14 inches in diameter marked "P", thence following the North line of said Kuffler Road in a southeasterly direction 365 feet, more or less, to intersection with the northerly line of State Highway No. 8 as now surveyed and established, thence in a northeasterly direction along the North line of said State Highway No. 8 to intersection with the East line of Section 26, thence North 42 feet, more or less, to point of beginning.
