THIS CONVEYANCE is intended as a MORTGAGE to secure the payment of FIVE HUNDRED TWENTY SEVEN and 03/100 DOLLARS, lawful money of the United States, together with interest thereon at the rate of six per cent. per annum from date until paid, according to the terms and conditions of _____ certain promissory note, bearing date March 17, 1948, made by the parties of the first part hereto, payable \$50.00 per month, the first payment to become due June 1, 1948, after date to the order of SECURITY STATE BANK, White Salmon, Washington and these presents shall be void if such payment be made according to the terms and conditions thereof.
