Beginning at the point of intersection of the south line of Olive Avenue in Boyd and Wilkinsons Addition to the Town of Carson, with the west line of Wind River Road; thence along the west line of said Wind River Road southerly 100 feet; thence westerly 100 feet; thence northerly 100 feet to south line of said Olive Avenue; thence easterly on said south line of said Olive Avenue 100 feet to point of beginning.
