That the said party of the first part for and in consideration of the sum of one dollar, and for the purpose of vesting in the party of the second part the title to the property hereinafter described as her sole and separate property, does hereby GRANT, BARGAIN, SELL and CONVEY unto the said party of the second part the following described real property in Skamania County, State of Washington, to-wit:
