Witnesseth; that the said party of the first part, for and in consideration of the sum of One Dollar and other valuable consideration lawful money of the United States to him in hand paid by the said parties of the second part, the receipt whereof is hereby acknowledged, does by these presents, REMISE, RELEASE, and forever QUIT CLAIM unto the said parties of the second part and to their heirs and assigns all right, title, interest and estate of said party in and to all that certain lot, piece or parcel of land situate, lying and being in the County of Skamania State of Washington, and particularly bounded and described as follows, to-wit:

All right, title and interest in that certain right to use of a certain spring as shown in reservation in deed from Caleb J. Moore to Christ and Harper, recorded in Deed Records "N" Skamania County, Washington at page 282, which recites as follows; "Reserving a right to the use of a spring and to run an inch pipe from a certain spring situated about 15 rods from the East line and near 20 rods from the South line of the above tract of land, the right of the spring and pipes to be retained forever to the Grantor herein."
