FEDERAL FARM LOAN AMORTIZATION MORTGAGE

KNOW ALL MEN BY THESE PRESENTS, That on this 22nd day of June, 1948, Elmer Crispin and Doris J. Crispin, husband and wife, hereinafter called the mortgagors, hereby grant, bargain, sell convey and mortgage to THE FEDERAL LAND BANK OF SPOKANE, a corporation organized and existing under the Federal Farm Loan Act as amended, with its principal place of business in the City of Spokane, County of Spokane, State of Washington, hereinafter called the Mortgagee, the following described real estate situate in the County of Skamania, State of Washington, to wit:

Parcel I: Part of the Southeast Quarter of the Southwest Quarter and of the Southwest Quarter of the Southeast Quarter of Section Thirty-three, Township Two North, Range Five East of the Willamette Meridian, and part of the Northwest Quarter of the Northeast Quarter and of the Northeast Quarter of the Northwest Quarter of Section Four, Township One North, Range Five East of the Willamette Meridian.

Beginning on East line of West two-thirds of John W. Stevenson and wife Donation Land Claim 54 rods and 26 links North of the Southeast corner of said West two-thirds of said Donation Land Claim, being the Northeast corner of 8 acre tract deeded to Bernard Haffey (Vol. E - page 220); thence North along the East line of said West two-thirds of said Donation Land Claim 87 rods 6 links to a point 17 rods 20 links South of the North line of said Donation Land Claim, thence West parallel to said North line 17 rods 20 links; thence North to the North line of said Donation Land Claim; thence West along said North line 14 rods 16 links to a point 557.04 feet West of the Northeast corner of said West two-thirds of said Donation Land Claim; thence West 88 rods 13 links along said North line of said Donation Land Claim; thence South 105 rods 1 link to the North line extended of said 8 acre Haffey tract; thence East along said extended line and North line of said 8 acre tract to beginning.
