Know All Men by these presents, That Phillip Aaron Larsen a widower, when property was acquired and at all times since, of the County of Skamania, in the State of Washington, in consideration of the benefits and other valuable considerations, and the sum of Three Hundred and 00/100 Dollars, in hand paid, the receipt whereof is hereby acknowledged has GRANTED, BARGAINED, SOLD and CONVEYED, and by these presents does Grant, Bargain, Sell and Convey unto the State of Washington, the following described parcel of land situated in Skamania County, in the State of Washington, to-wit:

A strip of land being all that portion of following described tract that lies between lines, parallel with, and distant respectively 50 feet on northward side and 50 feet on southward side (measured at right angles) from the center line of said State Road No. 8, Underwood-West, as surveyed over and across:

That portion of Gov. lot 2 and the NE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 21, Township 3 North, Range 10 East of the Willamette Meridian, commencing at the point of intersection of the north line of County road, as now constructed through said lot 2, with the east line of said section 21; thence north, along said section line, 90 feet, more or less, to a small creek; thence southwesterly, along the said creek, to the north line of said county road; thence easterly, 100 feet, more or less, along the north line of said road, to the point of beginning.
