County Treasurer's Deed.

This Indenture, made this 17th day of April, 1934 between A. C. Sly, as Treasurer of Skamania County, State of Washington, party of the first part, and Gus Carlson party of the second part;

Witnesseth, That Whereas, at a public sale of real estate held on the 4th day of October, A. D. 1930, pursuant to an order of the Board of County Commissioners of the County of Skamania, State of Washington, duly made and entered, and after having first given due notice of the time and place and terms of said sale; and

Whereas, in pursuance of said order of the said Board of County Commissioners, and of the Laws of the State of Washington, and for and in consideration of the sum of Thirty Dollars, lawful money of the United States of America, to me in hand paid, the receipt whereof is hereby acknowledged, I have this day sold to Gus Carlson the following described real estate, and which said real estate is the property of Skamania County, and which is particularly described as follows, to-wit:

Sly, County Treasurer of said County of Skamania, State of Washington, in consideration of the premises, and by virtue of the statutes of the State of Washington in such cases made and provided, do hereby GRANT and CONVEY unto Gus Carlson heirs and assigns forever, the said real estate hereinbefore described, as fully and completely as the said party of the first part can by virtue of the premises convey the same.
