Witnesseth, That the said party of the first part, for and in consideration of the sum of One Dollar and other valuable considerations of the United States of America, to him in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged does by these presents, REMISE, RELEASE and forever QUIT CLAIM unto the said party of the second part, and to her heirs, assigns, all of my interest in and to the following described tract, lot, or parcel of land, situated, lying and being in the County of Skamania, State of Washington, particularly bounded and described as follows, to-wit:

Beginning at a point on the North line of Section 22, Township Two (2) North of Range Seven (7) East of the Willamette Meridian, 960 feet east of the Quarter corner, thence south 684 feet; thence North 54° 35' East 270 feet; thence North 1882 feet; thence West 223 feet; thence South 1336 feet to the place of beginning, containing 10.1 acres, more or less.

Together with all and singular, the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof.
