COUNTY TREASURER'S DEED

THIS INDENTURE, Made this 16th day of June, 1931 between A. C. Sly, as Treasurer of Skamania County, State of Washington, the party of the first part, and Esmeralda Lasher party of the second part;

WITNESSETH, THAT WHEREAS, at a public sale of real property held on the 4th day of October A.D. 1930, pursuant to an order of the Board of County Commissioners of the County of Skamania State of Washington, duly made and entered, and after having first given due notice of the time and place and terms of said sale; and,

WHEREAS, in pursuance of said order of the said Board of County Commissioners, and of the Laws of the State of Washington, and for and in consideration of the sum of Ten Dollars, lawful money of the United States of America, to me in hand paid, the receipt whereof is hereby acknowledged, I have this day sold to ESMERALDA LASHER the following described real property, and which said real property is the property of Skamania County, and which is particularly described as follows, to-wit:
