## SUPPLEMENTAL INDENTURE

This Supplemental Indenture dated as of the first day of January, 1948, by and between Wauna Lake Club, a corporation organized and existing under the laws of the State of Washington (hereinafter called the "Mortgagor"), party of the first part, and Portland Trust and Savings Bank, a corporation organized and existing under the laws of the State of Oregon (hereinafter called the "Trustee"), party of the second part as Trustee under the Indenture of Mortgage dated as of the first day of May, 1931,

WHEREAS the Mortgagor has heretofore executed and delivered to the Trustee its Indenture of Mortgage hereinafter referred to as the "Original Indenture", dated as of the first day of May, 1931 to secure an issue of seven percent First Mortgage Bonds of the Mortgagor in the aggregate principal amount of \$30,000, and

WHEREAS on or about the eighth day of November, 1933 more than eighty percent of
