Gates, an individual, the successor in interest to The Skamania Co-operative Telephone Association, a corporation, for and in consideration of the sum of One Dollar (\$1.00) and other valuable considerations to him paid by The Pacific Telephone and Telegraph Company the second party, the receipt of which is hereby acknowledged, does hereby assign, transfer and set over unto said The Pacific Telephone and Telegraph Company, its successors and assigns, forever, an undivided one-half (1/2) interest in and to the following described rights of way situate, lying and being in the County of Skamania, State of Washington, acquired by said The Skamania Co-operative Telephone Association and said Earl W. Gates from the following named parties by the following described conveyances, reference to which is hereby made for a more particular description of said rights of way:

- First: Bessie Young and Preston Ash right of way easement dated April 15, 1927 granting the right to erect and maintain poles with the necessary wires and fixtures thereon, across that certain property belonging to Preston Ash and Bessie Young, situate in Sec. Eleven (11) Township two (2) north, range seven (7), E. W. M., as more particularly described in said right of way easement, recorded in Book "V" of Deeds, at page 312, records of Skamania County.
- Second: Hugh B. Smith and Ida F. Smith, husband and wife: Right of way easement dated Sept. 12, 1928 granting the right to erect and maintain poles with the necessary wires and fixtures thereon across that certain property belonging to Hugh B. Smith and Ida F. Smith, husband and wife, situate in Sec. One (1), township two (2), north, range seven (7) E. W. M., as more particularly described in said right of way easement, recorded in Book "W" of Deeds at pages 45-6 records of Skamania County.
- Third: F. H. Hapgood and Lena Hapgood, husband and wife: Right of way easement dated Sept. 12, 1928, granting the right to erect and maintain poles with the necessary wires and fixtures thereon across that certain property belonging to F. H. Hapgood and Lena Hapgood, husband and wife, situate in Sec. One (1), township two (2) north, range seven (7) E. M.
