

## DEED RECORD X

SKAMANIA COUNTY, WASHINGTON

situate in Sections Fourteen (14), fifteen (15), twenty-one (21) and twenty-two (22) in Township two (2) North, Range Seven (7) East, of the Willamette Meridian in Skamania County, Washington, more particularly described as follows:

Beginning at the point of intersection of the west line of said donation land claim with the southerly limit of that certain tract of land conveyed by The Oregon Railroad & Navigation Company to Cascades Land & Investment Company as described in that certain deed of conveyance dated June 22, 1909, and recorded in Book "L", at page 464, of the records of deeds of said county of Skamania; thence easterly along said southerly limit on a curve to the right with a radius of 2965 feet, 866.2 feet, more or less, to a point which is 100 feet northerly, measured at right angles from the center line of the main track of the railroad of Spokane, Portland and Seattle Railway Company at station number 275+00 of the survey of said center line; thence north 9° 5' East 100 feet to a point; thence on a curve to the right with a radius of 3065 feet, 407 feet to a point; thence on a spiral curve to the right 172 feet to a point; thence on a tangent to said spiral curve south 71° 40' East 1099 feet to a point; thence on a spiral curve to the left 158 feet to a point; thence on a curve to the left with a radius of 2665 feet, 1503 feet to a point; thence on a spiral curve to the left 158 feet to a point; thence on a tangent to the last said spiral curve North 72° 50' East 910 feet to a point; thence south 17° 10' East 100 feet to a point; which point is 100 feet distant northerly from the center line of said railway; thence north 72° 50' East 538 feet to a point; thence on a spiral curve to the left 224 feet to a point; thence on a curve to the left with a radius of 1810 feet, 332 feet to a point; thence on a spiral curve to the left 224 feet to a point; thence tangent to last said spiral north 55° 16' East parallel with and 100 feet distant northerly, measured at right angles from the center line of the Spokane, Portland and Seattle Railway, 2880 feet to a point; thence north 73° 54' East 448 feet, more or less, to a point in the easterly line of said Chenoweth Donation Land Claim and in the south line of said tract of land heretofore conveyed to Cascades Land & Investment Company; thence south 42° 40' East along said easterly line 530 feet, more or less, to the southeast corner of said Donation Land Claim; thence southwesterly following the government meander line along the northerly bank of the Columbia River to the Southwest corner of said Donation Land Claim; thence north along the West line of said Donation Land Claim 950 feet, more or less, to the point of beginning, containing 97,286 acres, more or less, being all that portion of said Chenoweth Donation Land Claim Number 108 that lies between the southerly limit of said tract of land conveyed to Cascades Land & Investment Company and the meander line on the North bank of the Columbia River.

Chenoweth Donation Land Claim; thence North 109.8 feet to the place of beginning, containing 30.811 acres more or less and being all the shore lands of the second class lying in front of said Chenoweth Donation Land Claim Number 108 as conveyed to Oregon Railway and Navigation Company by the State of Washington by a certain deed of indenture dated July 14, 1896, and recorded on pages 60, 61, 319, and 320 of Book "E" of the records of deeds of Skamania County, State of Washington.

Parcel E:

All that portion of the D. F. Bradford Donation Land Claim Number 37, situate in Sections eleven (11) and fourteen (14) in township two (2) North, Range
