WHEREAS, on or about December 23, 1910, The Oregon Railroad and Navigation Company conveyed to Oregon-Washington Railroad & Navigation Company, a corporation organized and existing under the laws of the State of Oregon, all of the property of said The Oregon Railroad and Navigation Company, which conveyance was subject to the lien of the Mortgage and Supplemental Indentures; and said The Oregon Railroad and Navigation Company was dissolved and discontinued on or about March 1, 1911; and

WHEREAS, pursuant to the laws of the State of New York said New York Security and Trust Company on or about February 20, 1904, merged with Continental Trust Company of the City of New York, a corporation organized under the laws of the State of New York; and on or about March 1, 1905, pursuant to an order of the Supreme Court of the State of New York said New York Security and Trust Company by change of name became The New York Trust Company and under such name continued to be and now is the duly constituted Trustee under the Mortgage and Supplemental Indentures; and

WHEREAS, said Oregon-Washington Railroad & Navigation Company has fully paid, satisfied and discharged the Mortgage and the Supplemental Indentures and the obligations secured thereby and has requested the execution and delivery of this instrument; and

WHEREAS, the Mortgage and the Supplemental Indentures were recorded or filed as follows:
