Know All Men, That I George Henry Sampson of Twin Rocks, Tillamook County in the State of Oregon, of the age of 57 years, being of sound and disposing mind and memory, and not acting under duress, menace, fraud or undue influence of any person whomsoever, do make, publish and declare this my last will and Testament in manner and form following, to-wit:

First, it is my will, and I do order, that all my just debts and funeral expenses be duly paid and satisfied as soon as conveniently can be done after my decease.

Second, I give and bequeath unto my mother Mary D. Sampson all my property wheather real, personal or mixed and I leave to her the right to devide after her death as she sees fit.

And Lastly, I nominate, constitute and appoint Mary D. Sampson to be the executrix of this, my Last Will, without bonds hereby revoking all other Wills, Legacies and Bequests by me heretofore made and declaring this, and no other, to be my Last Will and Testament.
