One frame building located on the following described real property in Skamania County, Washington, to-wit:

A plot of ground 100 feet by 150 feet of the Southeast corner of a certain tract lying along the North Bank Highway and situated near the proposed Bonneville Dam Site in Skamania County, Washington and recorded in Skamania County, viz

Beginning at a point on the north line of State Road #8, 420 feet west on the section line between sections 21 and 22 township 2 North of Range 7 East of Willamette Meridian, in the Chenoweth Donation Land Claim, running thence north 150 feet, thence west 100 feet, thence south to the north line of State Road #8, thence following the north line of State Road #8 to the point of beginning,
