Johnson, party of the first part, for and in consideration of the sum of One Dollar, do hereby REMISE, RELEASE, CONVEY AND QUITCLAIM unto Anna M.Johnson, his wife, party of the second part, all his right, title and interest in and to the following described real property in Skamania County, State of Washington, to-wit:

Beginning at a point 40 rods South of the Northwest Corner of Section Nine, Township One North, Range Five, East of the Willamette Meridian, and running thence South 122 rods, more or less, to the North line of the old Cape Horn-Mt.
