THE GRANTOR Christina H. Cook, a widow of Berkeley, Alameda County, California for and in consideration of (\$1.00) One and no/100 Dollars, in hand paid, conveys and warrants to Northwestern Electric Company, a corporation, its successors and assigns, an easement or right-of-way for an electric transmission and distributing line of one or more wires and all necessary or desirable appurtenances (including telephone and telegraph wires, towers, poles, props, guys and other supports and including the right to place all said lines in underground conduits) at location and along the course now located and constructed by the Grantee over, across and upon the following described premises, located in Skamania County, Washington to wit:

Lot Two (2) and Northeast Quarter (NE $\frac{1}{4}$ ) of Northwest Quarter NW $\frac{1}{4}$  of Section Thirty-Five (35), Township Three (3) North, Range Eight (8) East, Willamette Meridian, said transmission line being located along and adjacent to the north boundary of the new State Highway over and across said property.

"Above contract covers payment for trees cut and other damages done in building the above described line".

Together with the right of ingress and egress over the adjacent lands of the Grantor for the purpose of constructing, reconstructing, stringing new wires on, maintaining and removing said lines and appurtenances, and exercising other rights hereby granted.
