PARCEL FOUR

A parcel of land containing 0.91 acres more or less bounded and described as follows: In the Southwest quarter of the Northwest quarter of Section fifteen, township four North range nine East, Willamette Meridian, containing from Station 238 plus 87 on a course of North 18 degrees 59 minutes East 287.3 feet, thence on a 2 degree curve right 19615 feet more or less to the East boundary of said Southwest quarter of the Northwest quarter of Section fifteen, right of way along the left side of the above described center line to be 20 feet and along the right side to be 60 feet in width.

PARCEL FIVE

A parcel of land containing 1.24 acres more or less bounded and described as follows: Commencing at Station 162 plus 27, a point on the South line of the Southwest quarter of the Northwest quarter of Section twenty three, township four North, range nine East, Willamette Meridian, said point being about 1015 feet East of the Southwest corner of said tract, thence on an 8 degree curve to the left 95.2 feet, thence North 49 degrees 35 minutes West 1233 feet to the West line of said tract, being 20 feet on each side of the center line.

PARCEL SIX

A parcel of land containing 1.18 acres more or less bounded and described as follows: Commencing at a point on the East line of the Southeast quarter of the Southwest quarter of Section fifteen, township four North, range nine East, Willamette Meridian, said point being Station 210 plus 40, thence North 49 degrees 35 minutes West 1280 feet to the North line of said tract, being 20 feet on each side of the center line.

TO HAVE AND TO HOLD, the same, together with all and singular the hereditaments and appurtenances thereunto belonging or in anywise appertaining to the said Skamania County, Washington, its successors or assigns forever.
