The East half of the Southeast quarter and the Southwest quarter of the Southeast Quarter of Section Seven, Township One North, Range Five, East of the Willamette Meridian; containing 120 acres, more or less, excepting a strip 18 rods wide and 90 rods long, along the South side of the above described land deeded to B. Jemtegaard.

All the West Half of the Southwest Quarter of the Southwest Quarter of Section Eight, Township One North, Range Five, East of the Willamette Meridian. (Subject to agreement with B. Jemtegaard to use of strip on South side of this tract for road purposes and certain water rights, as recorded in Book of Deeds, August 21, 1914, on page 80 of Book P, records of Skamania County, Washington.)

Subject to a mortgage to the Federal Land Bank for \$1600.00.
