I, D. L. Skidmore, having been duly sworn, on my oath depose and say:

That I am secretary of Table Rock Mineral Water Company, an Oregon Corporation, which is executing and delivering to John Tol deed covering the following described real Property in Skamania County, Washington, to-wit:

All that portion of the George W. Johnson donation land claim No. 38, lying in Section twenty (20), Township two (2) north, Range seven(7) east, Willamette Meridian, Excepting therefrom the following: Right of way of the Spokane, Portland and Seattle Railway Company; State Highway No. 8; that tract of land conveyed to R. V. Carpenter as described in conveyance recorded at page 439, book "S" of Deeds, Records of Skamania County, Washington; and subject to right of way granted to the Northwestern Electric Company, a corporation, for pole or tower lines thereover, containing 151 acres, more or less.

Said deed is dated April 6, 1934.

My attention has been called to the fact that the county assessor of said Skamania County, Washington, has apparently shown on the tax roll that said property is owned by Table Rock Water Company; that as far as I know there is no corporation by that name in Washington or Oregon; that all tax statements covering said property have been sent to Table Rock Mineral Water Company and the redemption certificate issued by the county treasurer of said county on December 15, 1931 shows that redemption was made by said Table Rock Mineral Water Company; that I am certain that the reference to Table Rock Water Company is an error on the part of the assessor and that the party which said assessor intended to name was Table Rock Mineral Water Company and not Table Rock Water Company.
