McNicholl, his wife, of the County of Skamania in the State of Washington, in consideration of the benefits and other valuable considerations, and the sum of Twenty and no/100 Dollars, in hand paid, the receipt whereof is hereby acknowledged have GRANTED, BARGAINED, SOLD and CONVEYED, and by these presents do Grant, Bargain, Sell and Convey unto the State of Washington, the following described parcel of land situated in Skamania County, in the State of Washington, to-wit:

A strip of land lying in the NW $\frac{1}{4}$, SE $\frac{1}{4}$, NW $\frac{1}{4}$ of Sec. 14 T. 3 N. R. 9 E. W. M., known as Lot 1 of the Oregon Lbr. Co. subdivision described as follows:

Beginning at a point on the present R of W line of existing County Road 30 ft. right of Sta. 50+68; thence southwesterly at right angles to the center line of said road, for a distance of 10 ft.; thence northwesterly parallel to the center line of said road for a distance of 420 ft.; thence northeasterly for a distance of 10 ft., to a point on the present R. of W. line of said County Road; thence southeasterly along present R. of W. line for a distance of 420 ft. to point of beginning, containing .09 acres more or less.
