Know all men by these presents, that Charles M. Walker and Lola E. Walker husband & wife in consideration of ten and 00/100 (\$10.00) Dollars to us paid by Nell Underwood do hereby GRANT, BARGAIN, SELL and CONVEY unto said Nell Underwood her heirs and assigns, all the following real property, with the tenements, hereditaments and appurtenances, situated in the County of Skamania and State of Washington, bounded and described as follows, to-wit:

That part of the Robbins Donation Land Claim No. 38, Certificate No. 288, being parts of Sections 26, 27, 34 and 35 in Township 3 North of Range 8 East of W. M. more particularly described as follows: Beginning at a point on the east line of said Robbins D. L. C. 40 chains south and 4 chains and 70 links east of the north-east corner of said section 27; and running thence south 40 chains to the section line between sections 26 and 35; thence west 20 chains; thence north 40 chains and thence east 20 chains to the point of beginning, said tract containing 80 acres, more or less, according to the public land survey thereof;
