John V. Manners et ux to State of Washington

In the matter of State Road No. 8, Cook East to Underwood West.

Know All Men by these presents, That John V. Manners and Elizabeth Fechteler Manners his wife, of the County of Skamania in the State of Washington, in consideration of the benefits and other valuable considerations, and the sum of One and 60/100 Dollars, in hand paid, the receipt whereof is hereby acknowledged have GRANTED, BARGAINED, SOLD and CONVEYED and by these presents do Grant, Bargain, Sell and Convey unto the State of Washington, the following described parcel of land situated in Skamania County, in the State of Washington, to-wit:

A strip of land being all those portions of following described tracts of land that lie northwardly from a line, parallel with and distant 80 feet southwardly measured at right angles from the center line of said State Road No. 8, Cook East to Underwood West, as surveyed over and across that portion of Government Lots numbered 3 and 4, of Section 29, Township 3 North, Range 10 East of the Willamette Meridian, lying southwardly of the Spokane Portland & Seattle R. Co's right of way.

Except: that from Engineering survey station 572 plus 00 to Engineering survey station 585 plus 00 said strip of land lies northwardly from a line, parallel with and distant 100 feet southwardly (measured at right angles) from the center line of said Road No. 8, and from the West line of said Government Lot 3 eastward to Engineering Survey Station 572 plus 00, said strip of land lies northwardly from a line, parallel with and distant 120 feet southwardly (measured at right angles) from the center line of said State Road No. 8, Cook East to Underwood west.

Reserving to the grantors herein all riparian and shore land rights to above described tracts after the construction of said State Road No. 8.

the specific details concerning all of which are to be found within that certain map of definite location now of record and on file in the office of the Director of Highways at Olympia and bearing date of approval March 6th, 1934.
