an Oregon corporation, hereinafter called the Grantees,

Witnesseth: That the said grantors, for and in consideration of the sum of \$10.00 and other valuable consideration to them in hand paid by the Grantees, receipt whereof is hereby acknowledged, do hereby GRANT, BARGAIN, SELL and CONVEY unto the said grantees, their heirs, successors and assigns, all the following bounded and described real property situated in the County of Skamania, State of Washington, more particularly described as follows, to-wit:

Parcel 1. The SW $\frac{1}{4}$ of Sec. 26 tp. 2 N. R. 5 East of the Willamette Meridian, containing 160 acres, more or less.

Parcel 2. The SE $\frac{1}{4}$ of Sec. 27, Tp. 2 N. R. 5 East of the Willamette Meridian, containing 160 acres.

Parcel 3. The SW $\frac{1}{4}$ of SW $\frac{1}{4}$ of Sec. #14 and the SE $\frac{1}{4}$ of SE $\frac{1}{4}$ of Sec. #15 and the West $\frac{1}{2}$ of NW $\frac{1}{4}$ of Sec. 23, all in Tp. #2 North Range 5 East of Willamette Meridian, containing 160 acres.

Parcel 4. SW $\frac{1}{4}$ of Sec. 23 Tp. 2 N., R. 5 East of the Willamette Meridian, 160 acres.

Parcel 5. The S $\frac{1}{2}$ of the NW $\frac{1}{4}$ and the fractional N $\frac{1}{2}$ of NW $\frac{1}{4}$ of Sec. 26 Tp. 2 N., R. 5 East of Willamette Meridian, excepting that part of said NW $\frac{1}{4}$ lying W. of the center of the Washougal River.

Parcel 6. The E $\frac{1}{2}$ of SE $\frac{1}{4}$ and the E $\frac{1}{2}$ of NE $\frac{1}{4}$ of Sec. 22, Tp. 2 N., R. 5 East of Willamette Meridian.

Parcel 7. The E $\frac{1}{2}$ of NE $\frac{1}{4}$ of NE $\frac{1}{4}$ of Sec. 27, Tp. 2 N., R. 5 East of Willamette Meridian.

Parcel 8. The E $\frac{1}{2}$ of SE $\frac{1}{4}$ of NE $\frac{1}{4}$ of Sec. 27 Tp. 2 N. R. 5 East of Willamette meridian.

Parcel 9. All that part of the NW $\frac{1}{4}$ of Sec. 26 Tp. 2 N., R. 5 East of W. M. lying west of the center of the Washougal River, containing 20 acres more or less.

Parcel 10. The NW $\frac{1}{4}$ of NW $\frac{1}{4}$ of Sec. 14, the NE $\frac{1}{4}$, the NE $\frac{1}{4}$ of SE $\frac{1}{4}$ and the W $\frac{1}{2}$ of SE $\frac{1}{4}$ of Sec. 15, Tp. 2 N. of range 5 East of W. M. containing 320 acres, excepting out of this deed and always reserving unto Hiram W. Sibley and wife, their heirs and assigns, a right-of-way over and across said lands for logging purposes, and free ingress, egress, and regress through said lands in and along the bounds or sides of the Washougal River for driving logs.

Parcel 11. Right-of-way acquired from Maggie Hanlon over the W $\frac{1}{2}$ of the NW $\frac{1}{4}$ of SEC. 34, and a right-of-way, acquired from Geo. F. Breslin over the NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ and the N $\frac{1}{2}$ of the NE $\frac{1}{4}$ of Sec. 33, Tp. 2 N. Range 5 East of the Willametter Meridian.
