Know all men by these presents, That George J. Johnson and Loleta M. Hopper Johnson his wife, of the County of Skamania in the State of Washington, in consideration of the benefits and other valuable considerations, and the sum of Six Hundred forty & 00/100 Dollars, in hand paid, the receipt whereof is hereby acknowledged have GRANTED, BARGAINED, SOLD and CONVEYED, and by these presents do Grant, Bargain, Sell and Convey unto the State of Washington, the following described parcel of land situated in Skamania County, in the State of Washington, to-wit:

A strip of land being all those portions following described tract of land that lie northwardly from a line, parallel with and distant 80 feet southwardly (measured at right angles) from the center line of state Road No. 8, Cook East to Underwood West and southwardly from a line parallel with & 50' northwardly from (measured at right angles) from said center line, except that from Engineering survey station 609 plus 00, eastward to the east line of following described tract, said strip of land is 50 feet wide on each side of the center line of said State Road No. 8, Cook East to Underwood West, as surveyed over and across those portions of Government Lots Numbered 1 and 2, Section 28, township 3 North, Range 10 East of the Willamette Meridian, described as follows:
