Northwestern Elect. Co. to State of Washington.

Borrow Permit.

Know All Men by these presents, That Northwestern Electric Company, a Washington corporation, for and in consideration of the sum of One Dollar, in hand paid to it, the receipt whereof is hereby acknowledged, does hereby GRANT UNTO the State of Washington, permission to take and remove rock, gravel, sand and earth from any portion of the hereinafter described tract of land, for the purpose of constructing, maintaining and repairing highways, at any and all times between the date hereof and December 31, 1938, together with the right to operate necessary equipment thereon for said purpose and with the right of ingress and egress for the purpose of removing said materials therefrom to the right of way of State Road No. 8, Cooks- East to Underwood- West Section; said tract of land being situated in the County of Skamania, State of Washington and more particularly described as follows, to-wit:

A strip of land, 100 feet wide, adjoining the right of way of the Spokane, Portland & Seattle Railway Company on the north side, and extending from Engineering Survey Station 522 plus 00 of said State Road No. 8, Cooks-East to Underwood-West Section, to the east line of Government Lot numbered 5, section 30, township 3 north, range 10 East, of the Willamette Meridian, as said road is now surveyed over and across Government Lots numbered 4 and 5, Section 30, township 3 north, range ten east of the Willamette Meridian, and shown on map of said road approved by the Director of Highways, March 6, 1934 and revised December 4, 1934.

The State of Washington, in exercising such permission, agrees to indemnify and save harmless said Northwestern Electric Company against any damage to said Company's transmission line that may be caused by or result from such use of said lands by the State, and in the event that any excavation on said lands shall, in the opinion of Northwestern Electric Company, endanger said transmission line, the State agrees to pay the cost of moving said line to the nearest available safe location.

If, as the result of any excavation or other work made or performed by the State of Washington upon said lands or the presence of machinery or other apparatus placed thereon by the State, any person shall be injured, the State of Washington will, and hereby agrees to, indemnify and save Northwestern Electric Company harmless from loss, damage or expense resulting therefrom.
