It further appearing that by an order heretofore made and entered herein this court fixed and set the Tuesday, the 4th day of September, 1934 at the hour of 9-30 o'clock a.m. of said day to be the time and this courtroom to be the place of hearing upon said final account, and that notice of such time and place of hearing was duly published as by law and said order required, in the Sunday Welcome, a newspaper published in, and of general circulation in said Multnomah County, Oregon and proof of which publication being now on file herein, and

It further appearing that no objections to said final account have been made or filed and that said final account is in all respects correct and regular and that no objections have been made on file thereto, and

It further appearing that all claims against the estate and expenses of administration have been fully paid, including taxes on personal property in the sum of Twelve and Sixty-one/100 Dollars (\$12.61) paid subsequent to the filing of the final account, and vouchers filed therefore, except the fees of Everett I. Adcock, administrator of said estate, and the fees of Eugene H. Dowling, attorney for said estate, for services rendered in the probating of the same; and

It further appearing that the said Everett I. Adcock has rendered services to said estate as administrator thereof for which he is entitled to compensation and that, as the attorney for said estate, the said Eugene H. Dowling has rendered professional services to said estate in the probating thereof for which he is entitled to a reasonable compensation and

It further appearing that the total value of said estate was less than Ten Thousand and no/100 (\$10,000.00), to-wit: the sum of Nineteen Hundred Eighty-five and 20/100 Dollars (\$1985.20) and that there is no inheritance tax due to the State of Oregon on account thereof and it further appearing that Minnie Sterling of Portland, Oregon is the wife of the decedent and is his sole heir-at-law and that upon the payment of said administrator's fees and attorney's fees this estate will be ready to close.

It is therefore hereby ordered, adjudged and decreed that the amount of the fees to be allowed to Everett I. Adcock, as administrator of said estate, be and the same is hereby fixed in the sum of \$119.00 and that the fee to be allowed to Eugene H. Dowling, attorney, for professional services rendered in probating the said estate be and the same is hereby fixed in the sum of \$119.00 and

It is hereby further ordered and decreed that said final account be and the same is hereby in all respects confirmed and approved and it is further ordered and decreed that Minnie Sterling, wife of above named decedent is his sole heir-at-law, and, after payment of said administrator's fees and attorney's fees, is entitled to a residue of this estate.

It is further ordered and decreed that the administrator pay forthwith the above mentioned administrator's fees and attorney's fees and deliver the residue of said estate to the said Minnie Sterling and file his vouchers therefore therein and that thereupon this estate be closed.
