The Grantor, Moffetts Hot Springs Co., a Washington corporation, for and in consideration of the sum of Ten (\$10.00) Dollars and other good and valuable consideration, does hereby CONVEY and WARRANT unto R. L. Harris and Doris E. Harris, husband and wife, herein-after referred to as the grantees, the following described real property, to-wit:

Beginning at a point on the southerly line of the Evergreen Highway, which said point is south 81° 00' East 250 feet from a point which is south 1257 feet and west 38.93 feet from the common corner of sections 15, 16, 21 and 22 in township 2 north of range 7 East of the Willamette Meridian and running thence south 81° 00' East, along the southerly line of said highway, 50 feet; thence south 9° 00' West 100 feet; thence north 81° 00' West 50 feet; and thence north 9° 00' East 100 feet to the place of beginning, said tract being designated as Lot 4, Block 2, of the unrecorded plat of the town of North Bonneville, Skamania County, Washington.
