This covenant shall run with lands of said Lumber Company adjoining said Spokane, Portland & Seattle Railway Company's right of way in Sections 28 and 21, Township 3 North, Range 10 E. W. M. and shall bind the heirs, executors, administrators and assigns of said Lumber Company.
