Power of Attorney.

Know all men by these presents, That I, William B. Taber, of the city of Alpena, County of Alpena and State of Michigan, have MADE, CONSTITUTED and APPOINTED, and by these presents do Make, constitute and appoint Nettie P. Taber, of the same place, my true and lawful attorney, for me and in my name, place and stead, to sell, pledge, exchange, deliver and transfer any stocks or bonds, warrants or other evidences of indebtedness now owned or hereafter acquired by me, to collect and receive all sums of money due, or to become due to me, and to give all necessary receipts, releases and acquittances therefore; to sell, assigns, transfer or discharge any and all mortgages now owned by me or which I may hereafter acquire; to buy and sell securities and other property for me and on my behalf; to make, sign, endorse and deliver checks, notes and bills in my name and behalf; to sell, and convey and to execute and deliver deeds of conveyance containing such covenants as she shall deem necessary with respect to any real estate which I may own; to make and execute income tax certificates and reports or returns for me and in my name, and generally to transact all of my business affairs to the same extent and with the same effect as if transacted by myself; this power to continue until revoked by me, giving and granting unto my said attorney full power and authority to do and perform all and every act or thing whatsoever requisite and necessary to be done in and about the premises, as fully to all intents and purposes as I might or could do if personally present, with full power of substitution and revocation, hereby ratifying and confirming all that my said attorney or her substitute shall lawfully do or cause to be done by virtue thereof. The right to make transfer of this power of attorney at a later date when and if such action is advisable is hereby vested in said Nettie P. Taber.
